## General Rules for Advertising Sales

Advertising is available to Chamber members only. Don't forget that you can sell a package of advertising and membership. Dues must be current and members must be in good standing before advertising contracts will be accepted.

In order to receive credit for advertising sales, the advertising contract must be completed in full with authorized signature.

Ads are sold on Incentive Plan 1.

Advertising trade outs must be pre-approved by Mark Schenthal, 859-578-6383

Advertiser must supply camera-ready artwork. Chamber cannot absorb the cost of ad production (this includes trade outs).

### **Advertising Trade outs**

Trade outs for advertising must be pre-approved by Chamber staff. Do not waste your time pursuing a deal that has not been properly cleared in advance. Trade outs submitted, but not pre-approved, will not be accepted.

All rules and guidelines pertaining to "cash advertising" also apply to "advertising trade outs." A completed trade out contract must accompany the advertising contract. If both documents are not submitted, your team will not receive credit.

If the advertising trade out is to cover the cost of a membership, make sure the trade out amount and all documentation reflect the complete transaction. Also, don't forget to complete a membership application. All documents must be submitted at the same time.
